## Guidelines for International Hospitals

Medicare is a platform for healthcare service providers to introduce facilities and specialties to visitors. We would like to emphasize that Medicare is not a health camp nor a hospital, but an exhibition which provides public education for both the visitors and exhibitors. All international healthcare providers who interact with the public must follow the norms and ethics of the country and will be penalized if they do not adhere to it.

1. **No treatments can be done at the exhibition hall.**
2. **No consultation.**
3. **No prescription.**
4. **No Organization can advertise their doctors' success in treatments.**
5. **No person should claim that he / she has the sole authority on a particular subject or is the only person who could perform a particular procedure in the exhibition.**
6. **Organizations can not publish individual doctors' names/ photographs on the exhibition backdrops.**
7. **No organization can carry out advertisements on television / radio broadcasts, or announcing of names, specialties and qualifications of the doctor.**
8. **On TV / Radio Discussions, it is preferable if more than one doctor participates in the program.**
9. **Those who are writing articles or are interviewed by the press, should refrain from publishing photographs of individual doctors.**

### Instructions to Applicants

1. A duly completed application form along with a non refundable advance payment should be handed over to the Event Manager - AITKEN SPENCE CONVENTIONS & EXHIBITIONS and due acknowledgment and a receipt obtained (Please refer attached documents for Stall Rates, Discount Schemes and Payment details).
2. Stalls will be confirmed only upon receiving the advance payment and stalls will be allocated on "First Come First Served Basis".
3. Prime Space Exhibitors will receive only bare space along with a 15 Amp 230V power outlet in their stand rental. All stand building must be supplied by the Exhibitor themselves including cabling, wiring, carpets, furniture, electrics, walling etc. (Additional power and fittings will be provided through our supplier at a nominal cost).
4. Upon receipt of all applications the Organizers will process and allocate the stalls as requested (If available).
